Mr. Milum explained that both Feather Ridge Subdivision and Valle Alto East Subdivision, Phase 5 were approved by the Planning and Zoning Commission, Naismith/Hanson Engineering and the city staff. Feather Ridge Subdivision is located east of the new City Hall property and will consist of 42 single family homes. Valle Alto East Subdivision, Phase 5 is a continuation of the development on the south side of Whipple Road and will consist of 41 single family homes and 40 multi-family unit (20 duplexes). Both subdivisions will present the final plats for approval by the Planning and Zoning Commission in June so the Council can consider approval in July.

Mr. Milum explained that progress is being made on the new development by the city hall and the fire department and ambulance service. The City agreed to partner with the fire department, the ambulance service, the rodeo committee and the stock show in trying to get a road constructed hopefully with a grant or the coutny's assistance. The street needs to be named. The developer has named the street on the east side of the city hall

Ocelot Drive. Mr. Milum was given 2 names and he is sure that there are more. One name is Rodeo Drive for obvious reasons since the rodeo is the single largest event for Los Fresnos and brings many visitors and increased business to our community. The other name is Memorial Drive. Since we will have the Veterans Memorial in front of the City Hall this name fits really well too. Mr. Milum spoke to the developers of Feather Ridge and they were okay with the street being names Memorial Drive.

There was discussion on different names and possibly naming roads after individuals from this community. Mr. Milum suggested we develop a policy before that is done.

Mayor Narvaez suggested that the name be Veterans Memorial Drive.

Motion was made and seconded to name the street on the west side of the new city hall property Rodeo Drive and the street on the east side of the new city hall property Veterans Memorial Drive.

Consideration and ACTION to approve an agreement with the Los Fresnos Volunteer Fire Department and the Los Fresnos Ambulance Service on the lease of the current Emergency Services Building.

Mr. Milum explained that the fire department and ambulance service utilize the building they are presently in under a lease that was originally for 99 years. The agreement has between 70 and 75 years left before it expires. When the building was originally built with grant funds for the exterior and both organizations paid to have it completed in the interior. No one remembers exactly how much was spent that long ago but it was between \$75,000 and \$100,000. The fire department and the ambulance service could continue using the building until their lease expires using the area for storage and for vehicles not utilized as often. They prefer to have everything under one roof at the same location but funds are tight. The City could use the building for a storage facility and garage. We desperately need the room for vehicles and all kinds of storage. Mr. Milum would like for the City to buy out the agreement for \$100,000. The fire department and ambulance service could use the funds for being able to complete their facility and make it large enough for the current needs as well as long into the future. This would continue to show the City's strong commitment to both organizations for the great services they provide the citizens of Los Fresnos. We would budget the funds in the 2017-2018 budget.

Mr. Milum explained that this project is the 2015/2016 CDBG Grant Project 7216300 with TDA for street improvements which include East Sixth Street from Pita Street to Coma Street and East Ninth Street from South Arroyo Boulevard to Coma Street. There were 8 bids received with M.J.A. Construction, LLC being the low bidder on alternate bid A.1 in the amount \$178,541.78. Since the alternate bid is under budget and is a total reconstruction of the streets the recommendation is to go with M.J.A. Construction LLC instead of the low base bid of \$147,661.50 by G.N.H for partial reconstruction.

Mr. Milum and Ms. Smith answered questions from the Council.

Mr. Milum explained that when the original contract with BRW was approved we agreed that the price would be between 8% and 12%. Our budget (loan) is \$2,500,000 so the final contract was set based on that. The total is \$265,000 which is 10.60%.

Consideration and ACTION to approve the first, second and final reading of Ordinance 481 on the sale, use and discharge of fireworks in the City of Los Fresnos.

Mr. Milum explained that the ordinance needed to be updated to reflect a permanent structure that stays up all year long and a temporary structure that is brought in only for that particulat time and then removed. Since these structures need to be inspected each year or each time they are brought into the City, we included fees of \$500 annually for a permanent structure and \$300 each selling season for a temporary structure. We have to review quite a few things including the site plan, setbacks, distances from other structures, parking, lighting, restroom facilities as well as it being inspected by Code Enforcement, the Fire Marshal and the Building Inspector. Everything else in the ordinance remains the same.

Mayor Narvaez stated that we should put something in the ordinance when the temporary building has to be moved out of the city. This was discussed and the Council felt like 10 days was sufficient time for the building to get moved.

Motion was made and seconded to approved Ordinance 481 on the sale, use and discharge of fireworks and to add building must be removed within 10 days after selling date.

Consideration and ACTION to approve the first reading of Ordinance 482 fixing the rates to be charged to the consumers of water and sewer services.

Mr. Milum explained that there has been a practice in effect for many years before he got here to not charge for sewer service while a structure was under construction, under remodel, for sale or rent as long as no one was living in the structure. Under these circumstances no one is using the sewer. Our ordinance does not specifically say there should not be a charge in these circumstances so finance will not follow us to continue to follow this practice even with my authorization. It is not fair to contractors to force them to pay for sewer service they will not use while a structure is being constructed or remodeled and it is not fair to owners of property to force them to pay for sewer service they will not use while they are trying to sell or rent the house since no one is living there. He does not see that as being a friendly community wanting houses or businesses to be constructed, rented or sold. He added language to allow for this so it will be clear. The new language says, "There shall be no charge for furnishing sewer service to a structure being constructed, a structure being remodeled, a structure that is for rent or a structure that is for sale as long as it is not inhabited.

Part of the settlement of the East Rio Hondo Water Supply Corporation lawsuit was to remove the language that we would sell water to the Town of Indian Lake. That part has been removed from the ordinance.

Additionally, Pam removed all of the areas of the ordinance where it referenced fees since all of those were changed a year or so ago and put in a fee schedule. No fees were changed.

Ms. Gonzales handed out a paper to the Council were she had estimated the amount of funds that the City is losing by not charging sewer to the contractors and property owners.

This item was discussed in length by Council.

Mayor Narvaez stated to set up a special meeting to discuss this further being very specific on how this would occur and be monitored.

Mr. Milum explained that is also has been a practice in effect for many years were not to charge for cart (garbage) service while a structure was under construction, under remodel, for sale or rent as long as no one was living in the structure. The contractor is required to have a roll-off or the contractor hauls the trash himself and if no one is living in the structure while it is up for rent or sale there is no need for a trash cart. It is a needless expense to the contractor or owner and costs the City nothing. Our ordinance does not specifically say there should not be a charge in these circumstance so finance will not allow us to continue to follow this practice even with my authorization. It is not fair to contractors to forcde them eo pay for a cart (garbage service) they will not use while a structure is being constructed or remodeled or a property owner selling or renting a house that is not being lived in thus not producing trash but forcing them to pay for a cart (garbage service). I do not see that as being a friendly community. I have added language to allow for this.

Additionally, Pam removed all of the areas of the ordinance where it referenced fees since all of those were changed a year or so ago and put in the fee schedule. No fees were changed.

Ms. Gonzales stated that the garbage lost is included on the paper she gave them with the sewer.

This was discussed in length by the Council.

Mayor Narvaez stated to also have this on the special meeting being very specific on how this would occur and be monitored..

No action was taken.

Discussion on placing donation items on water bill.

Mr. Milum stated from time to time we are asked the question why is the \$1 donation on the water bill for the fire department and can we add another worthy group. The fire department donation was put on the water bill many years ago to help fund the department when the city only provided the fire department \$4,000 per year which did not even pay for their fuel bill. The monthly donation amount is between \$950 and \$1,000. With over 1800 customers, that means many have asked that it be removed. The donation is voluntary.

Other groups could be added if the council decided.

TML attorneys recommend that the City be careful with adding more. People could question it if it does not directly benefit all residents of the City. With the fire department is easily covers that. Also it could lead to residents not liking the additions and getting mad at the City and not donating for any.

Since we were not familiar with the donation process, I though it would be good to only discuss this and if you thought we should consider other options you would have time to consider any and all of them and make a decision.

There is a need for peer to peer counseling especially for those veterans and their families dealing with post-traumatic stress. The Veterans will be provided peer to peer counseling, financial assistance and counseling, medical expenses, groceries, utilities, transportation, assisting with claims. educational classes, information sharing and similar type activities. Mr. Milum prepared an agreement between the City and the the Warriors United in Arms Brownsville Veterans for \$1,000 if Council approved.

Mr. Milum reported on the following:

- A. Wastewater Plant Update We are working to get bid documents ready to begin advertising for the chlorine contact basin and the sludge drying beds. Hopefully we can award a contract in July. The headworks portion will need to be designed first taking about 120 days and then approval by TWDB. Once that is done we can advertise and begin construction in the late summer or early fall.
- B. Water Plant Update Guzman & Munoz Engineering is working on the detailed items that need to be done by a contractor to include as part of the study he is doing so we can hopefully get funding through TWBD. They are also looking to see if there is a less expensive way to install a bypass now that will help tremendously. They have been doing some wate testing this week to be able to design the plant to met new requirement and testing that will be in place in the near future.
- C. Water & Wastewater Engineering Study Guzman & Munoz Engineering continues to work on design, surveying, easements on property required for east and west Highway 100 as well as north on FM 1575. They are also studying all the existing water and wastewater lines in the city to determine which need to be replaced for various reasons. City staff is trying to get all the right of entries for possible easements.
- D. Whipple Road Wastewater Extension Naismith-Hanson Engineering is working on that project and will hopefully have some preliminary plans to review soon.
- E. Nature Park Naismith-Hanson Engineering has the Master Plan complete. Now they will begin working on the specific details so we can convert that to a bid package.
- F. Hike & Bike Trails The easement has been signed. Halff Associates is working on the final design, the timeline and a construction estimate. They will be providing plans so we can get final approval from Cameron County Drainage District #1, Bayview Irrigation District #11 and TxDot.
- G. Montes-Castro Park Final documents are being prepared for bids. We hope to have bids to approve in July or August.
- H. TxDot Sidewalk Projects The sidewalk project is almost complete. They look good.
- I. Welcome Sign The foundation is poured. They will start constructing the blocks and the stone in the next couple of weeks. It's going to happen.

This is a rate increase that we handle almost every year with Texas Gas and we just did with AEP. They apply to increase rates. All the cities combine efforts to assure the rates don't go up more than absolutely necessary. Usually the rates still go up but not as much. The legal representation is paid for through Texas Gas Service.

MODEL STAFF REPORT REGARDING TEXAS GAS SERVICE COMPANY'S STATEMENT OF INTENT TO INCREASE RATES IN THE RIO GRANDE VALLEY SERVICE AREA

ACTION MUST BE TAKEN TO SUSPEND THE EFFECTIVE DATE ON OR BEFORE JULY 20, 2017

On June 15, 2017, Texas Gas Service, a Division of ONE Gas, Inc. ("TGS" or "Company"), filed a Statement of Intent seeking to increase gas utility rates within the incorporated areas of the Rio Grande Valley Service Area ("RGVSA"). The affected Rio Grande Valley municipalities include the cities of Alamo, Alton, Brownsville, Combes, Donna, Edcouch, Edinburg, Elsa, Harlingen, Hidalgo, La Feria, Laguna Vista, La Joya, La Villa, Los Fresnos, Lyford, McAllen, Mercedes, Mission, Palm Valley, Palmhurst, Palmview, Penitas, Pharr, Port Isabel, Primera, Progreso, Rancho Viejo, Raymondville, Rio Hondo, San Benito, San Juan, Santa Rosa, and Weslaco, Texas ("RGV Cities"). In the filing, the Company asserts it is entitled to a \$4.54 million revenue increase from RGV Cities or an 18.35% increase over current adjusted revenues, excluding gas costs.

TGS has received annual rate increases in each of the past eight years based on a cost-of-service ("COS") tariff approved by the cities. Under the COS tariff, it was not necessary for cities to pass suspension resolutions. However, the COS approved last year required the Company to file a traditional rate case in 2017. A traditional rate case requires cities with original jurisdiction to act to suspend, deny, or approve the Company filing within 35 days from the date of filing. Cities must pass the suspension resolution by July 20, 2017.

The law provides that a rate request made by a gas utility cannot become effective until at least 35 days following the filing of the application to change rates. TGS has proposed an effective date of July 20, 2017. The law permits the City to suspend the rate change for 90 days after the date the rate change would otherwise be effective. If the City fails to take some action regarding the filing before the effective date, TGS' rate request is deemed administratively approved.

The purpose of the resolution is to extend the effective date of the Company's proposed rate increase and service area consolidation to give the City time to review the rate-filing package. The resolution suspends the July 20, 2017 effective date of the Company's request for the maximum period permitted by law to allow the City to evaluate the filing, determine whether the filing complies with law, and if lawful, to determine what further strategy to pursue, including settlement and ultimately to approve reasonable rates. The Resolution must be passed before July 20, 2017.

Explanation of "Be It Ordained" Paragraphs:

- Section 1. This section incorporates the "whereas" provisions in preamble into the Resolution.
- Section 2. This section confirms that the City is authorized to protect the interests of the City and TGS customers residing in the City.
- Section 3. The City is authorized to suspend the rate change for 90 days after the date that the rate change would otherwise be effective so long as the City has a legitimate purpose. Time to study and investigate the application is always a legitimate purpose. Please note that the resolution refers to the suspension period as the "maximum period allowed by law" rather than ending by a specific date. This is because the Company controls the effective date and can extend its effective date and, therefore, extend the deadline for final city action to increase the time that the City retains jurisdiction (for example, if necessary to reach settlement on the case). If the effective date is not otherwise extended by the Company, the City must take final action on TGS' request to raise rates by October 19, 2017.
- Section 4. This section authorizes the hiring of outside attorneys and consultants to work on this matter. Geoffrey Gay has represented at least some portion of RGV Cities in each of the prior COS rate filings by TGS. Likewise, Mr. Nalepa has been the consultant evaluating TGS files in each of the COS filings.
- Section 5. This section provides that the City shall work in coalition with the other affected Rio Grande Valley municipalities to review and evaluate TGS's filing.
- Section 6. By law, the Company must reimburse the cities for their reasonable rate case expenses. Legal counsel and consultants approved by Cities will present their invoices to the City of McAllen which will then seek reimbursement from Texas Gas Service. The City will not incur liability for payment of rate case expenses by adopting a suspension resolution.
- Section 7. This section merely recites that the resolution was passed at a meeting that was open to the public and that the consideration of the resolution was properly noticed.
- Section 8. This section provides that both TGS' designated representative and counsel for Cities will be notified of the City's action by sending a copy of the approved and signed resolution to certain designated individuals.
- Section 9. This section identifies the effective date of the Resolution as the time it is adopted.

Recommendation

The City Staff recommends adoption of the resolution suspending the effective date of TGS' proposed rate increase.

WHEREAS, on or about June 15, 2017, Texas Gas Service Company, a Division of ONE Gas, Inc. ("TGS" or "Company") filed with the City of Los Fresnos ("City") and the other affected Rio Grande Valley municipalities a Statement of Intent seeking to increase gas utility rates within the incorporated areas of the Rio Grande Valley Service Area effective July 20, 2017; and

WHEREAS, the City is a gas utility customer of TGS and a regulatory authority with an interest in the rates and charges of TGS; and

WHEREAS, the Gas Utility Regulatory Act § 104.107 grants local regulatory authorities the right to suspend the effective date of proposed rate changes for ninety (90) days; and

WHEREAS, the City retains its rights as a city with original jurisdiction including the right to suspend the application; and

WHEREAS, the City's consultants and attorneys recommend that the City suspend the application for further review.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOS FRESOS, TEXAS:

- **SECTION 1**. That the findings and recitations set out in the preamble of this Resolution are found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes.
- **SECTION 2**. That the City is authorized to protect the interests of the City and protect the interests of TGS customers residing and conducting business within municipal limits.
- **SECTION 3.** That the July 20, 2017 effective date of the request to increase rates submitted by TGS on or about June 15, 2017, be suspended for the maximum period allowed by law to permit adequate time to review the proposed changes and to establish reasonable rates.
- SECTION 4. That the City joins the City of McAllen and the other Rio Grande Valley municipalities in this proceeding and, subject to the right to terminate employment at any time, hereby authorizes the hiring of Geoffrey Gay of the law firm of Lloyd Gosselink Rochelle and Townsend, P.C., and Karl J. Nalepa of the consulting firm of ReSolved Energy Consulting, L.L.C. to review the Company's filing, negotiate with the Company, make recommendations regarding reasonable rates and to direct any necessary administrative proceedings or court litigation associated with an appeal of city action.
- **SECTION 5.** That the City shall work with the City of McAllen and other affected Rio Grande Valley municipalities in the review and evaluation of whether the proposed rates are appropriate, fair, just, and reasonable; and, intervene as a necessary party in the Railroad Commission of Texas' consideration of the TGS rate filing as it affects the customers in the unincorporated areas of the Rio Grande Valley region.
- **SECTION 6.** That the City's reasonable rate case expenses shall be reimbursed in full by TGS.
- **SECTION 7.** That it is hereby officially found and determined that the meeting at which this Resolution is passed is open to the public as required by law and the public notice of the time, place, and purpose of said meeting was given as required.
- **SECTION 8**. That a copy of this Resolution shall be sent to Stacey McTaggart, TGS at 1301 S. MoPac Expwy., Suite 400, Austin, Texas 78746 and to Geoffrey Gay at Lloyd Gosselink Rochelle & Townsend, P.C., 816 Congress Avenue, Suite 1900, Austin, Texas 78701.
- **SECTION 9.** That this Resolution shall be and become effective from and after its adoption.

Emergency Operations Plan mutual aid Memorandum of Understanding (MOU), which calls for both authorities to establish and maintain a coordinated program for enhancing Emergency Operations Planning Response, between Los Fresnos Consolidated Independent School District hereby after known as Los Fresnos CISD and The City of Los Fresnos, acting by and through their respective Board of Trustees, pursuant to authority granted under the Interlocal Cooperation Act, Chapter 791, Texas Government Code, as the same may be amended from time to time.

WHEREAS, Los Fresnos CISD and The City of Los Fresnos are subject to danger and damage anytime from flooding, tornadoes, high winds, lightning, hazardous material incidents and other acts of nature or terrorism; and

WHEREAS, Los Fresnos CISD and The City of Los Fresnos propose this Memorandum of Understanding (MOU) to establish a formal working Mutual-Aid relationship between Los Fresnos CISD and The City of Los Fresnos in support of Emergency Operation planning, response and recovery programs; and

WHEREAS, the mission of the Los Fresnos CISD Emergency Operation's Plan is to administer a campus-based comprehensive emergency management program in partnership with The City of Los Fresnos and its neighboring jurisdictions to safeguard lives and property; and

WHEREAS, in light of their respective common goals to reduce the loss of life and property from natural or manmade emergencies or disasters, Los Fresnos CISD and The City of Los Fresnos recognize the need to maintain a strong coordination at a level that ensures efficient use of all available resources, consistent with the principles of each entity; and

WHEREAS, Los Fresnos CISD and the City of Los Fresnos agree to encourage, coordinate, promote, and support an ongoing relationship between both entities and to hold periodic partnership meetings to focus on, but not limited to, identifying and assessing an all hazards approach and associated risks, particularly as they relate to Los Fresnos CISD and The City of Los Fresnos; and

WHEREAS Los Fresnos CISD and The City of Los Fresnos would benefit from the development and adoption of this MOU; and

WHEREAS, both parties agree, but not limited to the following:

- Cooperate in all areas of mutual interest as it relates to Emergency Management: sharing data, information, planning, response, recovery, and other operational support programs;
- Enhance and maximize both Emergency Management program capabilities of both participants for the purpose of protection of the public health and safety, the public school environment, and to preserve and safeguard property;
- The City of Los Fresnos Emergency Management program is designated the primary warning control point for Los Fresnos CISD emergency notification and/or warning devices when a serious external threat exists for the school division;
- Provide a rapid coordinated and effective response with full utilization of all resources
 of both participant jurisdictions, including any resources on hand or available that are
 essential to the safety, care and welfare of those impacted in the event of an emergency
 or disaster declared by the jurisdiction;
- In the event of a declared emergency, those resources identified in the City of Los Fresnos Emergency Operations Plan (EOP) and held by Los Fresnos CISD will be made

- available as rapidly as possible without endangering the care, welfare, safety, or security of the students or employees of Los Fresnos CISD;
- Each jurisdiction shall appoint an individual representative to serve as a point of contact for matters relevant to this MOU;
- This MOU becomes effective on the date of execution and shall remain in effect unless terminated by written notification by either jurisdiction to the other;
- This MOU may be amended by written mutual agreement.

Miscellaneous Provisions

- Notwithstanding any provision to the contrary herein, this Agreement is a contract for and with respect to the performance of governmental functions by governmental entities. The services provided for herein are governmental functions, and the Parties shall be engaged in the conduct of a governmental function while providing and/or performing any service pursuant to this Agreement.
- The relationship of the Parties shall, with respect to that part of any service or function undertaken as a result of or pursuant to this Agreement, be that of independent contractors.
- Nothing contained herein shall be deemed or construed by the Parties, or by any third party, as creating the relationship of principal and agent, partners, joint venturers, or any other similar relationship between the Parties.
- Each Party covenants and agrees, to the extent permitted by law, that each Party shall be solely responsible, as between said Party and the other Parties to this Agreement, for and with respect to any claim or cause of action arising out of or with respect to any act, omission, or failure to act by said Party or its respective employees, contractors, subcontractors, agents, representatives, or assigns, in the provision of services pursuant to this Agreement.
- The Parties covenant and agree, to the extent permitted by law, to release each other for any claims or cause of action arising out of or with respect to the failure of either party to provide the resources outlined in this Agreement. The Parties agree that this Agreement is only an Agreement to share resources on an as available basis and not an obligation to do so.
- Each Party reserves and does not waive any defense available to it at law or in equity as to any
 claim or cause of action whatsoever that may arise or result from or in connection with this
 Agreement. This Agreement shall not be interpreted nor construed to give to any third party the
 right to any claim or cause of action, and neither Party shall be held legally liable for any claim or
 cause of action arising pursuant to or in connection with this Agreement except as specifically
 provided herein or by law.
- Neither Party waives or relinquishes any immunity or defense on behalf of itself, its trustees, council members, officers, employees, and agents as a result of the execution of this Agreement and the performance of the covenants and agreements contained herein.
- If any provision of this Agreement shall be deemed void or invalid, such provision shall be severed from the remainder of this Agreement, which shall remain in force and effect to the extent that it does not destroy the benefit of the bargain.
- This Agreement is the entire agreement between the Parties as to the subject matter hereof and supersedes any prior understanding or written or oral agreement relative to the subject matter hereof. This Agreement may be amended only by written instrument duly approved and executed by all Parties in accordance with the formalities of this Agreement.
- All Parties agree that this Agreement shall be construed under the laws of the State of Texas, and obligations under the Agreement shall be performed in Cameron County, Texas.

WHEREAS, the Superintendent of Los Fresnos CISD has considered this Multi-Jurisdictional MOU and has determined that it is in the best interest of the school district to approve such MOU.

?As you are likely aware, the Texas legislature recently amended TLGC §42.0235, which greatly restricts the extent of Cameron County municipal ETJs and left areas of ETJ-less "no-man's land" between neighboring cities in Cameron County. Through the new amendment, cities in Cameron County can opt out of this restriction by enacting resolutions after June 1, 2017. I've attached a copy of this code section with the new provisions underlined.

By enacting said resolutions, Los Fresnos, Bayview, Indian Lake, and Brownsville can keep the status quo as we've agreed to in previous interlocal agreements (Brownsville's 2009 relinquishment of ETJ to neighboring cities) and not be restricted by §42.0235 prior to its amendment this year. Brownsville will be bringing resolutions to our City Commission meeting coming up on July 11, 2017. I've attached versions of the resolution to each city from our email, and would ask that you please pass similar resolutions (feel free to use mine as a template--I don't have the exhibits attached in this email, though) so that we can keep the municipal and ETJ boundaries we've agreed to and currently have.

Whereas, Los Fresnos and Brownsville have previously and satisfactorily resolved issues regarding extra-territorial jurisdiction (ETJ) and city limits by adopting valid and binding interlocal agreements, true and correct copies of which are attached as exhibits A and B; and

Whereas, both Los Fresnos and Brownsville wish to continue to give effect to those mutually-binding interlocal agreements, as they have worked well for both communities; and

Whereas, the Texas State Legislature has previously attempted to resolve certain issues in Cameron County regarding ETJ by enacting Texas Local Government Code §42.0235, which statute provided a different manner of calculating ETJ in Cameron County than that uniformly employed throughout the rest of the State of Texas; and

Whereas, both Los Fresnos and Brownsville have previously agreed that calculating their respective ETJ under previously-enacted Texas Local Government Code §42.0235 to be detrimental and not in the best interest of each of their respective communities; and

Whereas, during the most recent legislative session in 2017, the Texas Legislature amended Texas Local Government Code §42.0235 by amending §42.035(a) and adding §42.0235(d), which specifically provides that municipalities affected by previously-enacted Texas Local Government Code §42.0235(a) could mutually opt out of the ETJ calculation provided by the statute, by way of a resolution enacted after June 1, 2017; and

Whereas, both Los Fresnos and Brownsville have expressed a willingness to opt out of the ETJ calculation provided by previously-enacted Texas Government Code §42.0235(a), pursuant to newly-amended and enacted §42.0235(a) and (d), and continue to calculate their ETJ using the same scheme employed in the rest of the State, as voluntarily modified by those interlocal agreements attached as exhibits A and B;

IT IS THEREFORE RESOLVED AS FOLLOWS:

Introduced and ADOPTED on July 11, 2017

- I. That the City of Los Fresnos finds that calculating its ETJ pursuant to previouslyenacted Texas Local Government Code §42.0235 is not to be in its best interest, as said statute limits both its ability to plan municipal services and its ability to enforce the state subdivision ordinance in the areas immediately outside its city limits; and
- II. That the City of Los Fresnos agrees to calculate its ETJ pursuant to Texas Government Code §42.021, as further modified by the interlocal agreements attached to this resolution as Exhibits A and B, which agreements are further ratified as valid and binding interlocal agreements.
- III. That this Resolution shall have immediate effect, and shall be valid upon the passage of a mutual resolution by the City of Brownsville.

Dear Governor Abbott,

As the special session approaches, our community would like to voice our concerns regarding the current proposed solutions for property tax reform involving property tax caps and lowering rollback rates. We encourage you to please consider working with us to determine an exemption for rural and smaller communities in Texas. We recommend an exemption apply to counties with populations under 200,000 and municipalities with 50,000 or less so our community can continue to fund items such as public safety spending, new infrastructure and services to our constituents for rural and smaller local governments.

It's time to allow budgeting to reflect reality and find alternative ways to help small and rural municipalities and counties balance their community's needs with the law; please reconsider the "one-size fits all approach" being considered. Possible exceptions for smaller and rural communities could include:

- (1) Exempt rural and smaller counties and cities based on population,
- (2) Exempt rural and smaller counties and cities based on total budget or
- (3) Exempt rural and smaller counties and cities based on any jurisdiction that experienced a 10% or larger loss of revenue due to economic or natural disaster.

Additionally, property tax is no longer sustainable as the sole source of funding for public education. School finance reform needs to be addressed before true property tax relief can occur. The Legislature should focus on the real issue that leads to rising tax bills to all property owners in this state: school districts levying more in property taxes because the state's system for funding education is not properly funded. It is high time for us to come together in the spirit of bipartisanship to develop and enact new and lasting solutions to the ongoing burden of rising property taxes on Texas homeowners.

Finally, unfunded state mandates affect the cost of local government, and how they are passed on to the taxpayers. The proposal to cap the roll back rate on local taxes may sound enticing, but in reality it is just another example of the state abdicating its responsibility. Make no mistake... it's the local services that your constituent's all want (law enforcement, highway maintenance,

economic development, health, etc.). However, our savings and reserves for local services end up being utilized to stabilize and reduce taxes in the face of increasingly expensive State mandates.

Lowering the property tax rollback rate does nothing to reduce or eliminate the current State mandates imposed on local government. Furthermore, if State mandates cause communities and counties to have an election to increase the overall property tax cap, the proposal unfairly shifts the blame for tax increases to local elected officials when the tax increases are actually caused by the State. Thus, reforming unfunded mandates can allow Texas to make their tax system more transparent, efficient, and equitable at the same time.

Our community understands the need for reducing property taxes, however please think how small and rural communities such as ours will be impacted. We encourage you and your staff to find a solution for these smaller, rural communities impacted by the proposed rollback tax so collaboratively we can continue to build a sound and robust Texas for all Texans.

Discussion, consideration and ACTION to approve the grant for Nature Park and detention area.

This was a 2 part grant with some for the High School and some for the City. The original award was to the school to re-habilitate their parking lot and drainage area (falcon lake) to be more environmental friendly. Since their project was quite large they were covering our match. The City would use funds for the bioswale drainage system that is part of the parking lot and the rain water harvesting system on the restrooms. If you will recall this allowed us to have sufficient funds to complete the parking lot and restrooms. The original amount for the City was \$67,100. However, the school could not wait to redo the parking lot and did the work before the grant was approved. In order for the grant to not be lost, we have updated it to be presented and hopefully approved. Since the school's project changed, they are requesting that they just utilize \$15,000 to upgrade the area around falcon lake but since they don't have the big paving project they do not have the match and would like us to cover that. We would get an additional \$52,100 to construct additional trails (now totaling \$119,200 with the drainage and rain water harvesting system). Our total match for the entire project would be \$89,467 which they will allow us to use the grant funds from TPW so it will cost the City zero local funds.

I'm working with Jaime to get all of the city of Los Fresnos and Los Fresnos CISD subcontract details put together for the Arroyo Colorado Watershed Protection Plan (WPP) Implementation – Los Fresnos Best Management Practices (BMPs) Implementation, 582-17-70357 (06-505448).

Since the scopes are being slightly modified and the budgets are being reorganized within each sub (total \$ is the same, but funds between categories are being updated slightly), is there any official paperwork we need to complete to do this? I know Jaime has been in contact with you, so you're aware, but I just wanted to make sure we don't skip a process that needed to be taken before we insert these into the subs and get the subaward paperwork all signed off on.

Subcontractor: Los Fresnos Consolidated Independent School District (CISD) / High School

Scope of Work

Los Fresnos CISD refurbished the high school parking lot in the summer of 2016. The High School and Parking lot sit in the bed of an abandoned Resaca and have issues with stormwater runoff and erosion after storm events. The LFCISD will install a series of stormwater BMPs designed to divert, slow down and treat the stormwater as part of a treatment train. The BMPs will channel the stormwater to a vegetated wetlands to minimize sediement and other pollutants in the stormwater flow. The project will teach and engage students to monitor water quality of the stormwater runoff from their high school parking lot along with providing real-world experiential-learning water quality monitoring in the STEM curricula at the High School. Educational/interpretive signage will be installed at the site to educate the public and other students. The budget estimates include the cost of supplies and materials to divert the stormwater from the parking lot to minimize erosion into the wetland; install diversion bars (speed bumps) to divert stormwater to curb cuts (BMPs to slow and divert stormwater within the parking lot); regrade and re-grass portions of vegetated strip at curb cuts; native trees for stormwater management; and educational/interpretive signage.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOS FRESNOS, TEXAS:

That Chapter 44 of the Code of Ordinances, City of Los Fresnos, Texas is hereby amended to read as follows:

ARTICLE I.

SECTION 44.4 PENALTY

(b). Further, as a civil penalty, the city secretary, in its sole discretion, not based on the outcome of any criminal proceeding, and as a completely separate action, may require the water to be cut off from the premises of the offending person until such person shall give the city secretary sufficient security against further violations of said rules and regulations and the provisions of this chapter, and, in case of persistent violation, the city secretary may forbid any further service to the party so offending.

SECTION 44.6 REOUIRED

CONNECTION OF WATER AND WASTEWATER SERVICES

- (a). Water service will begin to be charged when the water tap is completed and the water meter is installed.
- (b). Sewer service will begin to be charged when the sewer tap is completed.
- (c). Exceptions: Uninhabited structure means no one is occupying the structure for its normal use. Sewer service is not required when the structure will be uninhabited for a minimum of 3 months. If the 3 month minimum is not met, regular monthly fees for the elapsed time will be charged and due on the next billing cycle. Requests must be made for a specific time frame but not more than 6 months at a time. If the initial requested time has ended and subsequent request approved and begun, since the original 3 month requirement is fulfilled, charges will not be made if the projected time is not fulfilled. It is the duty of the account holder to notify the City of changes in status immediately. Failure to do so could result in fines being assessed as allowed. Approval must be obtained through the City.

SECTION 44.12 ESTABLISHING SERVICE CONNECTIONS; UNLAWFUL CONNECTIONS; UNLAWFUL USE AND SALE OF WATER

- (a). Required. Connection for any utility service furnished by the city shall be made only under the supervision of the City public works director, and every building, structure or consumer in the city shall have a separate utility service connection.
- (b). Application. Any person desiring to be connected with the water or sewer system shall make application in writing to the city secretary upon a form furnished by the city secretary for such purpose, and shall furnish all such information relative to the quantity of water likely to be consumed. The completed application shall be a part of the consideration for such water or sewer service. The application shall be submitted together with tap and connection fees, as applicable, and the service deposit required under this chapter.

SECTION 44.13 SERVICE RATES AND OTHER CHARGES; BILLING AND COLLECTION

- (d). *EDAP areas outside city limits*. The areas outside the corporate city limits that are recognized as EDAP are to be furnished water and sewer services under that program at the rates provided in the city fee schedule.
- (g). Water connection fees and service deposit. In addition to all other charges, each applicant is required to pay a non-refundable water connection fee and to make a water deposit in the amount of not less than the amount provided in the city fee schedule and no more than the consumption of water to be used by the applicant for two months, depending upon the class or character of the

residence or business or other class of user, as determined by the city secretary. The water service deposit shall be returned to the applicant or credited to the amount due for water by the applicant at the time service has been discontinued. The city secretary is authorized to increase the water service deposit at any time to an amount equal two months water usage. Deposits shall bear no interest.

- (h). Sewer connection and extension fees. All sewer connections will be made by city crews or contractors under the supervision of the City public works director or his designated representative or at the city's option by any person licensed by the state board of plumbing examiners as a master plumber or journeyman plumber. A sewer connection fee in the amount provided in the city fee schedule shall be paid for each single-family dwelling. A sewer connection charge is required for each dwelling unit within an apartment building or multifamily dwelling unit and commercial or industrial connections. Any cost to the city of making a sewer connection that exceeds the rates provided in the city fee schedule will be paid by requestor of sewer services. Any cost to extend sewer lines or increase capacity will be paid by the requestor of sewer services.
- (i). Billing; delinquencies and late fees; water shut-off and reconnection. Bills for water and wastewater service shall be paid to the city secretary on or before the 15th day of each month. If a bill is unpaid by the due date, the city secretary shall apply a 15 percent late penalty to the amount unpaid. If the delinquent amount plus late penalty is not paid by the 30th of the month, the city secretary shall cause the water service to be shut off and a processing fee assessed in the amount provided in the city fee schedule. Upon payment of all amounts due and a reconnection fee in the amount provided in the city fee schedule, service shall be re-established.

SECTION 44.14. METER INSTALLATION, MAINTENANCE, TESTING AND REPAIR; REPAIR COSTS.

(c). Should a consumer desire that his water meter be tested, he shall make application therefore to the city secretary, and with such application, he shall deposit a meter testing fee in the amount specified in the city fee schedule. Within ten days after such application, the city secretary shall cause such meter to be tested. If the testing shows that the meter so tested registers normal or correctly, or registers below normal, or less than the water actually used, the deposit shall be forfeited to the city and the consumer shall pay to the city the amount due because of such incorrect registering; but, if the testing shows that the meter so tested registers above normal, or more than the amount of water actually used, the meter testing fee shall be returned to such consumer and the city shall repay to such consumer the excess amount of three prior months therefore paid by such consumer to the city, because of such incorrect registering of the meter.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOS FRESNOS, TEXAS:

ARTICLE I.

That Chapter 34 of the Code of Ordinances, City of Los Fresnos, Texas is hereby amended to read as follows:

SECTION 34.1:

DEFINITIONS

The following words, terms and phrases, when used in this chapter, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Contract documents means the contractor's proposal, general specifications, this contract and any addenda or changes to the foregoing documents agreed to by city and contractor. Contract documents shall include the following documents, and this chapter does hereby expressly incorporate same herein as fully as is set forth verbatim in this chapter: RFP Bid Proposal.

Uninhabited Structure means no one is occupying the structure for its normal use.

ARTICLE II.

SECTION 34.21: CARTS.

(a).It shall be the duty of every person owning, managing, operating, leasing, or renting any premises to use a cart or dumpster provided by Allied Waste Services for the daily accumulation of solid waste. All solid waste is to be bagged prior to placing it in the cart or dumpster. The cart shall be placed on the curb or not more than five feet from the curb of the street in the front yard for pickup. Placing the cart, brush, or any solid waste on any street or alley within the city limits is prohibited. Carts are to be ready for pickup on the street by 7:00 a.m. each Tuesday for residents and commercial on the north side of Highway 100 and on Wednesday for residents and commercial on the south side of Highway 100. (on the scheduled day but no more than 24 hours before the scheduled time.)
(d). Exceptions:

- 1. New construction Cart Service or dumpster service is not required during the construction phase until the Certificate of Occupancy is issued. However, arrangements must be made with City solid waste contractor for construction debris removal or self-removal to the landfill. Construction debris cannot accumulate on site causing health concerns.
- 2. Uninhabited structures Cart service or dumpster service is not required when the structure will be uninhabited for a minimum of 3 months. If the 3 month minimum is not met, regular monthly fees for the elapsed time will be charged and due on the next billing cycle. Requests must be made for a specific time frame but not more than 6 months at a time. If the initial requested time has ended and a subsequent request approved and begun, since the original 3 month period requirement is fulfilled, charges will not be made if the projected time is not fulfilled. It is the duty of the account holder to notify the City of changes in status immediately. Failure to do so could result in fines being assessed as allowed. Approval must be obtained through the City.

SECTION 34.24: RECYCLING

(a). Allied Waste Services shall provide a recycle trailer with attendant once per week on Wednesday from 7:00 a.m. to 10:00 a.m. for fees charged to each residence and small business.

(b). Allied Waste Service shall provide two 30-yard roll-off containers per year for the disposal of rimless tires for fees charged to each residence and small business.

The City provides recycling at various locations and times each week. Contact City Hall or the City website for specific details.

ARTICLE III.

SECTION 34.28. FINES.

Any person, firm, corporation violating any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor and upon conviction shall be fined in any sum but not to exceed five hundred (\$500.00) dollars, and each such day violation continues shall constitute a separate offense.

SECTION 34.29. EFFECTIVE DATE

This Ordinance shall take effect immediately from and after its passage and the publication of the caption as per the City Charter.

- A. Wastewater Plant Update We are working to get bid documents ready to begin advertising for the chlorine contact basin and the sludge drying beds. Hopefully we can award a contract in July. The headworks portion will need to be designed first taking about 120 days and then approval by TWDB. Once that is done we can advertise and begin construction in the late summer or early fall.
- B. Water Plant Update Guzman & Munoz Engineering is working on the detailed items that need to be done by a contractor to include as part of the study he is doing so we can hopefully get funding through TWBD. They are also looking to see if there is a less expensive way to install a bypass now that will help tremendously. They have been doing some water testing this week to be able to design the plant to meet new requirement and testing that will be in place in the near future.
- C. Water & Wastewater Engineering Study Guzman & Munoz Engineering continues to work on design, surveying, easements or property required for east and west Highway 100 as well as north on FM 1575. They are also studying all the existing water and wastewater lines in the city to determine which need to be replaced for various reasons. City staff is trying to get all the right of entries for possible easements.
- D. Whipple Road Wastewater Extension Naismith-Hanson Engineering is working on that project and will hopefully have some preliminary plans to review soon.
- E. Nature Park Naismith-Hanson Engineering has the Master Plan complete. Now they will begin working on the specific details so we can convert that to a bid package.
- F. Hike & Bike Trails The easement has been signed. Halff Associates is working on the final design, the timeline and a construction estimate. They will be providing plans so we can get final approval from Cameron County Drainage District #1, Bayview Irrigation District #11 and TxDOT. We also were awarded \$200,000 trails grant through TPW so we will have \$700,000 to work with.
