Mr. Milum explained the no-new-revenue tax rate is \$0.553617 per \$100 valuation. In order to get the same revenue as last year the tax rate would be \$0.553617 instead of the actual \$0.705 per \$100 valuation. Mr. Milum answered questions from the council and discussed the tax rate.
