Mr. Milum stated this is the first reading of the ordinance to annex the 3.50 acres, 9.944 acres, and 10.00 acres located on the east side of the city limits on the south side of Hwy 100. The service plan is similar to the one we did for the areas annexed 2 years ago except since the annexation is voluntary the developers are responsible for extending water, sewer, streets, street lighting, drainage, etc.

Update by City Manager

A. Wastewater Plant Expansion B. Raw Water Line Upgrade, Filter Replacement, Sludge Removal System C. Development Projects - Paseo Point Apartments, Walmart D. Community Park Parking E. Los Fresnos Nature Park F. Hazardous Mitigation Plan G. Category 7 Projects submitted to MPONo Action

- A. Wastewater Plant Expansion We are still waiting on approval from TCEQ. Then TWDB will be able to give us final approval to start the bidding process.
- B. Raw Water Line Upgrade USDA has approved the contract for construction. The Notice to Proceed date is September 8 with the end of construction November 8. Filter Replacement Work is occurring at the contractors shop. Construction is scheduled to be

- complete December 6. Sludge Removal System Quite a bit of work has been done on site. Construction is scheduled to be complete October 6.
- C. Development Projects Paseo Point Apartments is scheduled to be complete by the end of the year. WalMart says they will open on March 19.
- D. Community Park Parking The work is complete and the parking lot is open. However the asphalt did not meet the thickness requirements so we area working with the County to determine the solution. The parking area on Nogal Street and Third Street is in the approval process.
- E. Los Fresnos Nature Park We are working to get a closing date as the property owner has agreed to the purchase. He would like us to have a plaque or something with his name on it indicating appreciation. I figured we could develop a small area with nice plants for a sign and maybe a large bolder with a sign on if with his name.
- F. Hazardous Mitigation Plan I was notified that the grant has been approved on the state level and is sent to the federal level for approval. They say it will be at least 30 to 60 days. We have not heard any more information.
- G. Category Projects Submitted to MPO We submitted Whipple Road, Los Fresnos Loop, Hike & Bike Trails and Henderson Road. The technical committee has completed the review and ranking of all the projects. We will not be getting any construction funds. We will be recommended to be awarded funds for engineering for Whipple Road and funds for about half of the engineering for the Los Fresnos Loop. The Policy committee will make the final decision on September 9.
