Public hearing to receive comments from the public on the proposed tax rate for Fiscal Year 2021-2022.

Last meeting on Tuesday August 10, I proposed to leave the tax rate the same as it has been for 15 years at \$0.715 per \$100 valuation. Since the no new revenue tax rate is \$0.690708 per \$100 valuation, we will receive an increase in revenue of \$77,446.83 so by law we have to hold 1 public hearing. It is an opportunity to hear from residents/taxpayers.

NOTICE OF 2021 TAX YEAR PROPOSED PROPERTY TAX RATE FOR CITY OF LOS FRESNOS

A tax rate of \$0.715000 per \$100 valuation has been proposed for adoption by the governing body of CITY OF LOS FRESNOS. This rate exceeds the lower of the no-new-revenue tax or voter approval tax rate, and state law requires one public hearing be held by the governing body before adopting the proposed tax rate.

The governing body of CITY OF LOS FRESNOS proposes to use revenue attributable to the tax rate increase for the purpose of covering the City operations.

The voter approval rate is the highest tax rate that CITY OF LOS FRESNOS may adopt before holding an election.


ACTION ITEM (ID # 4065)

Consideration and ACTION to approve the second Ordinance 529 re-zoning of Block 96, lots 1-14, Block 116, Lots 1-14, and Block 117, Lots 1-14 Los Fresnos Original Townsite from M-H Manufactured Housing to R-1 Single Family District.

This was passed on the first reading on Tuesday August 10 at the Council meeting. This area is near Mesquite Street and West 6th and West 7th Streets. It is currently zoned Manufactured Housing and the property owner wants to put a single family residence in the area. It is not allowed. In these 3 blocks, there are 23 single family homes, 7 mobile homes and 2 vacant lots. If it is changed to single family zoning, a mobile home can still be placed there if they request a conditional use. This seems like the best option to take. Planning & Zoning Commission approved this at their July 19 meeting.

I recommend approval.

SECTION 1. In accordance with Ordinance 235, Section 3, sub-section 3.0 Official Zoning Map, the area set forth and described Block 96, Lots 1-14, Block 116, Lots 1-14 and Block 117, Lots 1-14, Los Fresnos Original Townsite, Cameron County, Texas from MH Manufactured Housing District to R-1 Single Family District. and incorporated into the Official Zoning Map.

SECTION 2. The Official Zoning Map is amended to reflect the zoning as described and shown on attached Exhibit "A".

SECTION 3. This ordinance shall take effect immediately upon approval.
