# NOTICE OF 2018 TAX YEAR PROPOSED PROPERTY TAX RATE FOR CITY OF LOS FRESNOS

2.1.a

A tax rate of \$0.715000 per \$100 valuation has been proposed for adoption by the governing body of CITY OF LOS FRESNOS. This rate exceeds the lower of the effective or rollback tax rate, and state law requires that two public hearings be held by the governing body before adopting the proposed tax rate.

The governing body of CITY OF LOS FRESNOS proposes to use revenue attributable to the tax rate increase for the purpose of covering debt requirements for street repairs.

PROPOSED TAX RATE	\$0.715000 per \$100
PRECEDING YEAR'S TAX RATE	\$0.715000 per \$100
EFFECTIVE TAX RATE	\$0.662254 per \$100
ROLLBACK TAX RATE	\$0.820309 per \$100

The effective tax rate is the total tax rate needed to raise the same amount of property tax revenue for CITY OF LOS FRESNOS from the same properties in both the 2017 tax year and the 2018 tax year.

The rollback tax rate is the highest tax rate that CITY OF LOS FRESNOS may adopt before voters are entitled to petition for an election to limit the rate that may be approved to the rollback rate.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS  
FOLLOWS:

$$\text{property tax amount} = (\text{rate}) \times (\text{taxable value of your property}) / 100$$

Manuel Abrego Jr. signed up to discuss the issue on flooding. Mr. Abrego stated that he thinks that the public works and police department employees did a great job.

Mr. Abrego wants to know if the city could address a few issues. He walked around town to a few ditches and noticed they were full of grass and trees. He understood they were not the city's responsibility but the city should at least pick up a phone and call Cameron County Drainage #1 because all the canals in town belong to them. Plants are in front of the canal but if you get off and walk down the canal there is a lot of junk. He feels the city needs to address these issues.

Mr. Abrego stated that we pays taxes to Drainage District #1. They have a ton of money and are building a theme park. Instead of using the money to clean our drain ditches the are making a waterfall for the theme park he feels it is ridiculous. Mr. Abrego mentioned that if we know any one with the county, the Drainage District #1 Board is appointed by the commissioners board we need to make some phone calls and hold those people accountable. He feels we need to bite the bullet and clean out the canals and be prepared for next time.

He thanked the board.

The mayor thanked Mr. Abrego. Mr Narvaez stated the city was concerned about the drainage and it is an issue the city has been working on for many years and there has been improvements. He agreed that the city needed to do more and address a lot of those issues which are usually the same areas that have the problems. Mr. Narvaez stated that the city has been working on them but the bottom line is having the money and doing what we need to do. Mr. Narvaez wanted to make Mr. Abrego aware that the city would be addressing the issue.

### **Public Hearing**

#### **Public hearing to receive comments from the residents concerning an appeal on the Planning and Zoning Commission's denial of a request for a conditional use permit to build a duplex at Lots 1, 2 & 3, Block B, Townsite of Los Fresnos.**

Mayor Narvaez opened the public hearing at 6:15 p.m.

Mr. Milum gave a description of where the property was located on Canal Street.

Abel Garcia stated he had lived in Los Fresnos for basically all of his life. He lived at 320 Canal Street and had recently heard about the public hearing because his sister still lives on Canal Street. Mr. Garcia stated if the city would allow a duplex what's to say that a year or two, maybe five years from now, somebody won't want to set up a hotel in that area. He believes that if that happens the taxes for the people living in the area are going to go up high, and that was his only concern.

Manuel Cruz Jr stated that his residence was right next to the property they were talking about and all of the area there is zoned single family. He thinks it would really impact the quality of life for them because they are adjacent to the property where the duplex has been proposed. He asked the board to deny the request and keep that area zoned single family. One of the concerns they have is that they did not know who is going to live in that building. From his understanding the owner would not be one of them. He asked the



board to take the recommendation of the planning and zoning commission not to allow the duplex in that area. He thanked the board.

Manuel Abrego stated he too grew up in the area with Mr. Garcia. Mr. Abrego stated he was there for several reasons. One that he was there to assist Mr. Delgado, the owner of the property, because he didn't know any English and asked Mr. Abrego to help him. Mr. Abrego asked if the council had copies of the duplex. They did. Mr. Abrego stated that Mr. Delgado had been in Los Fresnos as a businessman for 28 years. He builds frame homes on a property on Highway 100. He also stated that Mr. Delgado invested in building warehouses off Arroyo Blvd which he rents out for businesses and is starting a warehouse on highway 100 near Tapias restaurant. Mr. Abrego explained that Mr. Delgado also purchased two small duplex's in town. He has a son who will take over the business when he retires and plans to move to Los Fresnos.

Mr. Abrego stated the if the council would look at the drawing of the duplex they would see that it is very nice. He was very disappointed with the Planning & Zoning Commission because not a single question was asked and everything was cut and dry. At the time Mr. Abrego did not know Mr. Delgado but the property was owned by his sister and his cousin who lives on 1st Street received the letter so he decided to accompany him to the meeting. Mr. Abrego stated the duplex would be very nice, have a garage, private fence and back patio. Mr. Abrego stated that Mr. Delgado would build a small simple house with no garage, carport, patio or fence and he would then sign the home up for Section 8 Housing if the conditional use permit did not pass.

Mayor Narvaez let the public know that because he allowed Mr. Abrego to speak longer then 3 minutes he was going to give the rest of the public more time to speak.

Manuel Cruz stated that his main concern was that he wasn't sure if Mr. Delgado knew everything Mr. Abrego was saying and maybe that was not what he wanted to portray, since it was stated if this is not approved it seems that he wants to build something substandard and that will bring the community down. Mr. Cruz also mentioned that the city has a board that already looked at the proposal and if the council appointed those members they should trust that they did their job and looked at this project.

Mr. Milum explained that Chief Gonzalez had been looking into participating with Port Isabel and other entities to purchase a fire arms training simulator. The Los Frenos Police Department command staff looked at and utilized the system and feel it will be useful training to the police officers. The idea would be to share the cost with the other entities. Mr. Milum stated the total price would be \$28,165.00. Los Frenoss portion would be \$5,633.00. He stated the money was available in the shooting range account and he recommened the council approve the purchase and the following item would be the budget amendment to move the funds.

Council member Munoz asked if the payment would be split in two payments of \$2,816.50. Mr Milum answered no because the money was available to pay it all this year.

Mr. Milum stated that one problem that sometimes we don't know is if people are paying their sales tax. He explained that the city never gets a listing from the State of Texas of who pays a sales tax by month. We never know if business remit their sales tax or not. This firm goes through the state to determine if the business are paying the sales tax and if they find any errors they will fix it. The firm's fee would be 35% of what they find. If they find zero we pay nothing.

Council member Munoz stated that this is going to far. The city should not go to the business to make sure they are filing their income tax. He believes that the business are big enough to know that they have to file their income taxes and if they don't its against the law for them not to. Mr. Munoz explained that to him its not right to go to each business and ask if they are paying their taxes and filing their tax returns. Also to be going to each house and asking if they filed an income tax and asking how much they received is just going to far.

Mr. Milum asked the council if he could clarify he was not talking about income tax it was about sales tax and it's only for businesses.
