A tax rate of \$0.715000 per \$100 valuation has been proposed for adoption by the governing body of CITY OF LOS FRESNOS. This rate exceeds the lower of the effective or rollback tax rate, and state law requires that two public hearings be held by the governing body before adopting the proposed tax rate.

Executive Summary

Cameron County will participate in Operation Stonegarden (OPSG) by increasing the presence of law enforcement officers in areas known to be used by illegal immigrants, smugglers, drug traffickers and criminal aliens with ties to terrorism or criminal organizations. Cameron County Sheriff's Office (CCSO), along with the assistance of thirteen (13) participating law enforcement agencies will work overtime hours to achieve a safe and secure border. The participation of these agencies, made possible by funding through OPSG, will significantly impact the ability of criminal organizations to operate within the Rio Grande Valley Sector's area of responsibility (AOR).

I. SITUATION

A. General Situation:

Border violence threatens the safety of the citizens of Texas and the nation. Cameron County shares 114 miles of border with Mexico, and 30 miles of coastal area containing 7 ports of entries and 4 international bridges. Cameron County is a prime target for illegal entries into the U.S. by immigrants and individuals involved in smuggling and other illicit activities. It is also a target for criminal organizations that support terrorism and/or engage in violent crimes to smuggle criminal aliens into the country. Cameron County is in great need of strengthening its law enforcement along the border.

Cameron County will work with several agencies to help identify, locate, apprehend, prosecute, and remove individuals who pose a threat to public safety and security. To achieve this goal, all participating agencies will share information and intelligence. Cameron County will also increase patrol presence along its borders during the months of April to July and October to December. Specifically, Cameron County will work with several local, state, and U.S. law enforcement agencies to target areas, including Highway 281, FM 1419, and Highway 4 to the mouth of the Rio Grande River, as well as the seven ports of entry.

It is expected that the County's increased enforcement activities will help to mitigate criminal activity by criminal organizations in Cameron County and reduce the threat of border incursions. However, Cameron County's efforts will not interfere with or serve as a substitute for enforcement of immigration laws. If any federal immigration violations are encountered, the County will refer these cases to U.S. Border Patrol.

B. Terrain/Weather:

Cameron County has a sub-tropical and sub-humid environment. Summers are hot, with temperatures ranging from 75 to a high of 100 degrees in July. Winters are mild with an average low of 50 to 69 degrees in January. Rainfall averages twenty-six inches per year and snowfall is exceedingly rare. The first freeze usually occurs in mid-December and the last in late January. Weather is not expected to pose a threat to operations. The terrain is mostly flat brush land with low lying shrubs and bushes and small trees. The highways targeted by Cameron County for this operation are all in good condition and should not present any problems for deputies patrolling these areas.

C. Criminal Element:

In the past 5 years, Cameron County has experienced a dramatic increase in crimes committed by or at the direction of the Mexican drug cartels. Six of the eight major Mexican cartels are currently operating in Texas: Los Zetas, the Sinaloa Federation Cartel, the Beltran Leyva Organization (BLO), La Familia Michoacána Gulf Cartel, Knight Templar (Templarios Caballeros), and the Juarez Cartel. These cartels maintain their operations in transporting marijuana, cocaine, heroin, methamphetamine and other illegal drugs through the major transportation corridors which lead from Cameron County (highways 77/83 and 281) to the lucrative drug markets of the United States. Cameron and Hidalgo counties are in one of the five major drug corridors in Texas.

The threat from Mexican cartels is particularly high due to the wide range of criminal activity in which they are engaged, both in Mexico and in Texas. Cartel members and associates are involved in the cross-border trafficking of people, weapons, drugs, and currency. Of particular concern is the use of cartel tactics in Mexico, which now include torture, beheading, intimidation, and terrorist tactics.

The Texas-Mexico border area is one of the most active drug smuggling areas in the United States. There are 27 land Ports of Entry (POEs) spread along the border, including El Paso, Del Rio, Eagle Pass, Laredo, McAllen, Brownsville, and numerous small border towns. These corridors coincide with clusters of POEs along the border, leading to major highways throughout the state. The Southwest Border remains the primary gateway for moving illicit drugs into the United States, mostly through overland smuggling.

II. MISSION

Cameron County Sheriff's Department, along with the assistance of thirteen (13) participating law enforcement agencies, will work together to raise border security by increasing law enforcement presence along the border and by sharing intelligence/information and expanding communication. The Cameron County Auditor's

Office will administer the funds for Operation Stonegarden but the project will support joint operational plans that utilize staff from each department.

III. EXECUTION

A. Management/Supervisor Intent:

The County will enforce local and state laws within its jurisdiction and will refer any enforcement of immigration laws to the U.S Border Patrol. In addition, Cameron County will work with RGV Operation Center (OPCEN) based at the Rio Grande Valley Sector Office of Intelligence (SIU) to maintain cohesive operations with all entities involved.

B. General Concept:

The County will conduct project activities along its US/Mexico border and at the seven ports of entry within its boundaries; however, it will refer any federal immigration law violations to the Border Patrol.

C. Specific Responsibilities:

Cameron County

Objective: To reduce the threat of border incursions and exercise risk management in relation to anti-smuggling efforts by increasing law enforcement presence and special operations on routes of border ingress and egress in targeted roads and its seven ports of entry.

Operation Stonegarden funding will be used for overtime, mileage, and equipment to increase law enforcement presence and patrol.

Cameron County Constables:

Precinct 1: Increase law enforcement presence and patrol activity in the area surrounding East Brownsville, State Hwy 100 Beach Access #4, 5, 6, Port Isabel, and Boca Chica Beach. Priority area of assignment is the Brownsville Border Patrol Station.

Precinct 2:

Increase law enforcement presence and patrol activity in the area surrounding West Brownsville and Olmito, State Hwy 48, State Hwy 511, Hwy 281 (along the river), South 77/83 Expressway, Veterans and Gateway International Bridge area. Priority area of assignment is the Fort Brown Border Patrol Station.

Precinct 3:

Increase law enforcement presence and patrol activity in the area surrounding San Benito and Rio Hondo, FM 1577, FM 1421, State Hwy 281, North

Expressway 77/83, and the Free Trade International Bridge area. Priority area of assignment is FM 1847 and FM 106, North Expressway 77/83.

Precinct 4:

Increase law enforcement presence and patrol activity in the area surrounding Los Fresnos, FM 2480, Hwy 100 and Hwy 510. Priority area of assignment is US281-FM 1421, FM 1731, and FM1577.

Precinct 5:

Increase law enforcement presence and patrol activity in the area surrounding La Feria, Los Indios, Santa Rosa, Combes, Primera, Palm Valley, Rangerville, North 281, FM 1479, FM 3067, FM506, Fm2556, State Hwy 107, North Bus 77/83. Priority area of assignment is US 281-FM 732, FM 2500, FM509, FM 1479, FM 506, and FM 2556. Provide assistance to the Harlingen Border Patrol Station.

Los Fresnos Police Department:

Increase law enforcement presence and patrol activity in the area surrounding State Hwy 100 and FM 1847. Provide assistance to the Brownsville Border Patrol Station.

Port Isabel Police Department:

Increase law enforcement presence and patrol activity in the area surrounding State Hwy 100 and State Hwy 48. Provide assistance to the Brownsville Border Patrol Station.

South Padre Island Police Department:

Increase law enforcement presence and patrol activity in the area surrounding State Hwy 100.

San Benito Police Department:

Increase law enforcement presence and patrol activity in the area surrounding Exp. 83, Bus 77, and surrounding southwest city limits and northeast city limits.

Laguna Vista Police Department:

Increase law enforcement presence and patrol activity in the area surrounding State Hwy 100 and FM 510.

La Feria Police Department:

Increase law enforcement presence and patrol activity in the area surrounding FM 506 and US Expressway 83. Provide assistance to the Harlingen Border Patrol Station.

Rancho Viejo Police Department:

Increase law enforcement presence and area surrounding Carmen Avenue/1732 and US Expressway 77.

Harlingen Police Department:

Increase law enforcement presence and patrol activity in the area surrounding Rangerville Rd., corridors from State Hwy 281, FM 509 and FM 800, US Expressway 77/83. Provide assistance to the Harlingen Border Patrol Station.

The County will help enforce state law and local ordinances against violators in the target areas to help reduce criminal activity associated with alien and drug smuggling. Cameron County will not enforce U.S. immigration laws.

D. Coordinating Instructions:

Each department will perform the same duties as normally accomplished; however, they will work all federally funded overtime in geographical locations at or near the international border in coordination with Customs and Border Patrol (CBP) personnel from the respective CBP station.
